What data do we collect?

Orixcom collects the following data:

- Personal identification information (Name, email address, phone number, etc.)
- Cookies, referring server data, etc.

How do we collect your data?

You directly provide Orixcom with most of the data we collect. We collect data and process data when you:

- Register online or place an order for any of our products or services.
- Voluntarily complete a customer survey or provide feedback on any of our message boards or via email.
- Use or view our website via your browser's cookies.

Orixcom may also receive your data indirectly from the following sources:

How will we use your data?

Orixcom collects your data so that we can:

- Process your order, manage your account.
- Email you with special offers on other products and services we think you might like.
- Improve our website and its utility for you and our customers, generally.

If you agree, Orixcom will share your data with our partner companies so that they may offer you their products and services.

When Orixcom processes your order, it may send your data to, and also use the resulting information from, credit reference agencies to prevent fraudulent purchases and/or misuse or unlawful use of our services.

How do we store your data?

Orixcom securely stores your data at with leading cloud service providers and encrypted using industry standard methods and protocols.

Marketing

Orixcom would like to send you information about products and services of ours that we think you might like, as well as those of our partner companies.

If you have agreed to receive marketing, you may always opt out at a later date.

You have the right at any time to stop Orixcom from contacting you for marketing purposes or giving your data to other members of the Orixcom Group.

If you no longer wish to be contacted for marketing purposes, please contact us.

What are your data protection rights?

Orixcom would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

- The right to access You have the right to request Orixcom for copies of your personal data. We
 may charge you a small fee for this service.
- The right to rectification You have the right to request that Orixcom correct any information you believe is inaccurate. You also have the right to request Orixcom to complete information you believe is incomplete.
- The right to erasure You have the right to request that Orixcom erase your personal data, under certain conditions.
- The right to restrict processing You have the right to request that Orixcom restrict the processing of your personal data, under certain conditions.
- The right to object to processing You have the right to object to Orixcom's processing of your personal data, under certain conditions.
- The right to data portability You have the right to request that Orixcom transfer the data that we have collected to another organization, or directly to you, under certain conditions.

If you make a request, we have one month to respond to you. If you would like to exercise any of these rights, please contact us.

What are cookies?

Cookies are text files placed on your computer to collect standard Internet log information and visitor behaviour information. When you visit our websites, we may collect information from you automatically through cookies or similar technology. For further information, visit *allaboutcookies.org*

Orixcom uses cookies in a range of ways to improve your experience on our website, including:

- Keeping you signed in
- Understanding how you use our website

What types of cookies do we use?

There are a number of different types of cookies, however, our website uses:

- Functionality Orixcom uses these cookies so that we recognize you on our website and remember your previously selected preferences. These could include what language you prefer and location you are in. A mix of first-party and third-party cookies are used.
- Advertising Orixcom uses these cookies to collect information about your visit to our website, the
 content you viewed, the links you followed and information about your browser, device, and your IP
 address. Orixcom sometimes shares some limited aspects of this data with third parties for advertising
 and marketing purposes.

How to manage cookies

You can set your browser not to accept cookies, and the above website tells you how to remove cookies from your browser. However, in a few cases, some of our website features may not function as a result.
